Community Benefit Report

While Tampa General Hospital's Jennifer Leigh Muma Neonatal Intensive Care Unit exemplifies the partnership between TGH and USF Health Morsani College of Medicine, it also illustrates how surpluses generated by TGH benefit the community.

Community benefit is defined as:

- Charity care and other financial assistance on behalf of uninsured and low-income persons
- Subsidized health services
- Financial and in-kind contributions to local charities
- Health professions education
- Research
- Community health improvement

Almost 80% of the babies cared for in the Jennifer Leigh Muma Neonatal Intensive Care Unit have Medicaid as their primary source of funding. However, Medicaid reimbursement covers only part of the cost of care, and the unreimbursed portion is considered part of TGH's provision of charity care.

Pediatric residents, neonatal fellows, and nurse practitioners in training all spend time in the Jennifer Leigh Muma Neonatal Intensive Care Unit and are part of the over \$12 million in health professions education that TGH spends on an annual basis.

TGH provides over \$1 million in support of other community not-for-profit organizations annually. The March of Dimes, a major outside funder of research on preventing birth defects, premature birth, and infant mortality is just one recipient of this financial support. In addition, the Jennifer Leigh Muma Neonatal Intensive Care Unit staff organizes walkers for the annual March of Dimes Walk for Babies and holds fundraisers to support March of Dimes research throughout the year.


